MEATBALL SLIDERS


INGREDIENTS

- 1 package savory butter Hawaiian rolls
- 2 tbsp. butter melted
- 1 tsp. garlic powder
- 12 frozen meatballs
- ½ cup marinara sauce
- 2 cups shredded mozzarella sauce

INSTRUCTIONS

1. Preheat the oven to 350 degrees.
2. Remove sliders from the package and use a knife to cut a circle out of the center of each bun. Press the center of the bun

- down to make a hole on top of each bun.
3. Brush the top and inside of each bun with butter and sprinkle the garlic powder over the top.
4. Add a small amount of cheese to the inside of each hole in the buns.
5. Press one meatball into the top of each bun.
6. Top the meatball with marinara sauce.
7. Sprinkle the remaining shredded cheese over the top of each meatball.
8. Bake in the preheated oven for 15 to 20 minutes until the meatballs are heated through and the cheese is melted.



application. After my video teleconference hearing with the Social Security judge and their expert witnesses, I was sure that my application would be approved. Everybody agreed with my case arguments, even the judge. Then the decision came in the mail several months later. This is when I learned that even the Social Security judge has a judge reviewing their decision. "Denied" was the outcome. This was the response to follow for the remainder of my appeals. Being told by the Social Security Administration that I had exhausted all of my case appeal avenues, I decided to find an attorney. I went online and began searching for the right attorney for my case. I live in Colorado, so naturally I began my search there. No one in Colorado seemed to fit the bill for what I was looking for, so I expanded my search. That is when I found Loyd J. Bourgeois, "Social Security Disability Attorney and Representative." He is in Louisiana! "We Handle Disability Cases Nationwide!" His ad says that, "Not being able to provide for yourself or your family is unbearably stressful," so I knew that this person understood what I was going through. I called Loyd, and we discussed my attempts and the denials that followed. Loyd openly stated that he typically does not handle cases in which the claimant has gone this far on their own, but something about my case was intriguing to him. I sent him a copy of the first hearing decision and denial. He could see that the judge's decision supported the approval of my case. After a short time discussing my case with his staff, he accepted my case, and the rest is history. This case has taken approximately two years

to get approval since my first filing. The Loyd J. Bourgeois office with Social Security Representative Christy Crotwell were able to have the denial decision reversed and get back pay for my case.
